State Mandates IRWD to Reduce Water use by 16%

On April 1, 2015, Governor Brown issued an Executive Order directing the State Water Resources Control Board (SWRCB) to impose water restrictions to achieve an aggregate statewide 25% reduction in potable urban water use. On May 5, 2015 the SWRCB adopted a regulation mandating that IRWD reduce potable water use by 16%. In order to implement this mandate, all IRWD customers will be required to limit their outdoor water use.

What Does the 16% Reduction Mean to OPA

Your July water bill will be calculated using the IRWD Allocation-Based Conservation rate structure. This structure provides you with a monthly indoor and outdoor water allocation. Indoor Water Allocation: is based on the default number of residents in a home and is 50 gallons per person per day. The default number of residents is also based on the type of home. Outdoor Water Allocation: Due to the Governor's mandate, IRWD will be reducing the outdoor water allocation. It will be based on drought tolerant landscaping irrigated with drip or a high efficiency irrigation system. For OPA, your landscape allocation is based on the irrigated area from aerial imagery (not a default), the actual daily weather and how much water your plants need to stay healthy (referred to as the evapotranspiration rate or ET). Variances from Standard Water Allocation

You may request an increase in your water allocation by asking for a variance. Variances are available if you have additional residents, medical needs, operate a licensed care facility in your home or have livestock. Your Bill Shows Allocation vs. Usage

Your water bill amount will vary depending on your monthly allocation and how much water you use. The graph above, found on your water bill, shows you when your usage exceeds allocation

^{*}A ccf, or one hundred cubic feet, is the basic measurement of water use. One ccf equals approximately 748 gallons.

Rates and Charges

The chart above provides an overview of your residential water rates. Charges in the Inefficient or Wasteful tiers indicate that you are using more water than your allocation.

- Turn Down your Irrigation Use: Reduce your outdoor watering.
- Check your Sprinkler Timer: Are you over watering your yard?

How Your Water Rates are Calculated

The IRWD Allocation-Based Conservation Rate Structure has two basic components that make up your water bill:

Cost of Water Calculation

- The amount of water used - inside & outside your home
- Calculated using cost of local & imported water

Your cost of water is based on how much water you actually used and whether you stayed within your monthly allocation for that billing period.

Service Charge Calculation

- Infrastructure costs
- Operation & maintenance costs

Daily operation and maintenance costs are funded mainly through user service charges.

Sample Bill Comparison

The two samples below show how using water efficiently can impact your bill and save you money. Each of these examples for single family customers takes the actual water used per month determined by the meter reading and then applies it using the tier rate percentage allocation. These sample bills are based on proposed rates for FY 2015/16.

Proposed Changes for Water Service Charges:

Fixed monthly charge based on meter size for the operation and maintenance of the water system.

For meters 1-inch and larger, there is a graduated schedule of monthly charges on a per-meter basis, ranging from \$25.75 for a 1-inch meter to \$108.15 for a 2"turbo meter. The current amount for your meter size appears on your bill.

- Watch your mail for an official notice from IRWD of proposed rates and charges.
- Soon, an online rate calculator will be available on www.irwd.com so that you can easily determine how the new rate structure and water allocation will affect your bill.
- In May & June 2015, we will continue to collect water allocation variance forms and work with OPA customers to reduce your outdoor water use.
- In June 2015, you will receive additional information on how to read your bill and how to sign up for online payments, etc.
- After July 2015, we will continue to provide you with information, rebates workshops and other ways to save water.
